Emirates British Nurseries are a group of outstanding nurseries dedicated to providing excellent childcare and education for your child. We follow the British Early Years Foundation Stage and the children receive the same standards of care and education they would receive from an accredited British nursery in the UK. We are committed in developing our service to ensure we continue to provide a premier pre-school for families within the UAE.

Your payment schedule will be as follows:

Total Registration Fees including registration fee, medical fee, deposit, access card and lanyard fee and uniform fee (where required) plus 3 post-dated cheques for the annual tuition fee are to be submitted upon registration.

- Payable by Cash/Card/ Cheque
- International online payments and transaction fees are not covered by EBN

Post-dated cheques for the termly tuition fee (including transportation if required) are to be written out to Emirates British Nursery.

Notes

- FS1 and FS2 Children must attend for 5 days.
- FS1 and FS2 Children finishing time on a Friday is 12 midday unless your child is registered in our afternoon activity class.
- Disney and Seaworld Children finishing time is 12:00pm unless an afternoon class is pre-paid.
- 2- and 3-day children have compulsory set days. Days to attend 3-day classes will be confirmed to parents.

Terms and Conditions

Re-Registration Fee

- AED 500 re-registration fee will be applicable to secure your child's placement for the new academic year.
- The re- registration fee will be deducted from your first term fee.
- If you wish to cancel your child's placement after submitting your payment for the new academic year and cancel before the 8th April 2026, your re- registration fee will be **refundable**.
- If you wish to cancel your child's placement after submitting your payment for the new academic year and cancel after the 8th April 2026 and before the first day of the new academic year/term your re registration and medical fee is non-refundable and your post-dated cheques will be refunded.
- After the 1st day of the new academic year/term our cancelation terms and conditions are applicable

During the Academic Year

- If a child joins at any time during the Academic year, the full amount of Registration, Medical, Tuition and other fees are payable. However, the Tuition fees and optional fees will be calculated on a pro-rata rate for that term depending on when the child has joined.

Child withdrawal before the Academic Year

- If a child withdraws for the new academic year and cancels online (or in writing) before 31st August (or child's first term), the registration fee, medical and deposit are non-refundable. The three post-dated tuition fee cheques will be refunded.

Child withdrawal during the Academic Year

- If you wish to withdraw your child after submitting your payment for the new academic year and then cancel after the 31st August, the registration and medical fee is non-refundable. Tuition Fee and optional fees (transportation and early class) if applicable will be refundable as follows.
 - Tuition Fee and optional fees (transportation and early class) if applicable will be refundable on a pro rata balance of fees paid.
 - Tuition Fees and optional fees will be charged for 1 month if a child attends/registered EBN for 2 weeks or less.
 - Tuition Fees and optional fees will be charged for 2 months if a child attends/registered EBN for more than 2 weeks and less than 1 month.
 - Tuition Fees and optional fees will be charged for that term if a child attends/registered EBN for more than 1 month.
- If a discount was applied and your child is withdrawn, in the event you are eligible for a partial refund this will be calculated on the full, non-discounted tuition fee.
- If a child will not continue at EBN for Term 2 (spring term) and Term 3 (summer term), cancellation online or in writing is required before the 1st December and if your child will not be continuing for the summer term, cancellation must be received before 1st March.
- Deposit - Refundable after the new academic year has commenced and one-month prior notice has been received to withdraw your child before the end of the current term of enrolment. (Outstanding fees or charges will be deducted from your deposit if not paid prior to end of child placement).
- Fees will not be refunded/transferred for absence including illnesses, government declared holidays as well as unforeseen nursery closures.
- Where the delivery of services is fully or partially interrupted due to government-enforced closure, fees remain payable for any period during which the service was available and delivered, including distance learning or any other alternative method deemed appropriate and approved by KHDA.

- If you wish to withdraw your child please complete the online withdrawal form which can only be accessed via EducoreParent application and submitted online or inform us in writing.

- Assessments records and KHDA transfer certificates will be made available to parents only when the fees are paid
- Failure to pay fees on time may lead to your child losing their seat.

Changes of Days and Timing

- If you wish to change timings, days or transportation etc. the nursery must receive one full month's notice in advance to cancel the following full term. Notice in writing before 1st December for Spring Term and before 1st March for the summer term.
